Guardianship in Florida*

Attorneys and other professionals who provide guardianship services will receive an overview of Florida Guardianship proceedings from start to finish. The course begins with the incapacity determination process, continues through the appointment of a guardian, administration of the guardianship and ends with termination. The course includes ethical considerations, including both statutory and rules of professional conduct, applicable in guardianship. Each participant will receive a comprehensive guide to guardianship and incapacity law in Florida, including pleadings, forms, etc.
