OPG changes lives:

Marcia F. was left alone, abandoned by family and forgotten in a nursing home after suffering a severe brain injury. Her doctor felt there was little reason to give Marcia basic medical treatment for a physical illness unrelated to her brain injury. According to the doctor, Marcia's quality of life was too poor. Once OPG was appointed Marcia's legal guardian, the OPG case manager changed doctors and strongly advocated that Marcia receive the medical care she needs and deserves.

Since 1986, the Office of Public Guardian has served persons throughout North Florida who have been diagnosed with debilitating cognitive impairments such as Alzheimer's Disease, other dementias, developmental disabilities, and traumatic brain injuries. OPG, Inc. is appointed legal guardian by court order when an individual has no family available to serve as guardian and no resources to pay for guardianship services. Every person is assigned a representative who visits regularly. The guardian makes medical decisions, manages finances, and selects appropriate residential placements, all under court supervision. Our primary objective is to ensure the needs of each person are met and services provided.
